Dear Mr. Forcier

RE: Complaint to the Law Society of Upper Canada.

It is quite unfortunate that you have made the choice not to respond to me as requested in my last letter. I cannot imagine how you, as a professional in this community, can be so arrogant and unprofessional as to tell me that you will not deal with me just because I do not have a lawyer.

You are very aware of the fact that I have been forced into bankruptcy by the adversarial family court process and that I have lost my job as a result and cannot afford to pay for a lawyer at the present time.

It appears to me that you are ignoring my correspondence as a part of a strategy to prolong legal proceedings and to tie up more of the courts valuable time by keeping the litigation process going and frustrations fired up on both sides.

Please be advised, that because you failed to respond to my reasonable request asking you to confirm whether it was you or Mr. Chaddah who was the solicitor on record for my wife, I have filed a formal complaint to the Law Society of Upper Canada based on your refusal to correspond with me and your verbal threats to ignore me if I did not have a lawyer.

It is truly unfortunate that lawyers such as yourself and your partner, Mr. Chaddah, seem to have little regard for children and families and will allow families to be pulled apart and destroyed using legal tricks and deception. As you know, both my wife and I are bankrupt

and suffering but it seems that you lawyers still seem to want us to fight even more and to make matters as difficult for our family as possible. While children and their families get torn apart it seems that you lawyers keep getting richer. It seems as well that when families run out of money, then Legal Aid steps in to keep on feeding taxpayer's money to the lawyers.

I hope that you will reconsider your decision not to correspond with me and to answer my correspondence as should be the proper and respectable thing to do. It is only my wish to deal with the legal issues as they develop and to move ahead with matters as quickly as possible using as little of the valuable court's time as possible. I am a loving father who cares about my child and who will fight to the very end to ensure justice for her and to ensure that her close and loving relationship with her father is maintained.

In spite of our differences it is my desire that we have mutual respect for each other and to deal with each other in the most respectful and professional way possible. I welcome your response and most of all, your cooperation.
