RE: Fraudulent documents and abuse of power by the FRO

I acknowledge receipt of several threatening letters including the most recent dated July 24th 2001.

On several previous occasions I have requested that the FRO provide me with legal documentation from the court, specifically the court order, that orders your involvement in my case. To date, the Family Responsibility Office has never responded to my requests.

To my knowledge there has never been any court Order ordering your department to collect child support nor authorizing the involvement of the FRO in my case nor did I ever fill out any information package which I understand is the normal prior to people being put on your collection roles. I know nothing of any court Order in this matter.

It is my belief that the document which you have sent me and which you claim is a legal document is a fraudulent document with no legal basis. I believe that the FRO is claiming the authority to take action against me when in fact it has no legal authority to do so. It seems that the FRO is prosecuting me just because I'm a father.

Again, I am requesting that you provide me with a certified true copy of the judge's handwritten endorsement that supposedly allows you and your band of collection thugs to get involved in my case. From speaking to others, I have heard that court documents have been found to have been fraudulently altered by lawyers and even court staff solely to disadvantage a father and to allow conniving and unethical lawyers to violate the laws with impunity.

I have collected all kinds of articles and letters about the Family Responsibility Office and it appears that your department is out of control with your workers afraid to give out names and instead having to hide behind numbers. Your building is like a fortress with television cameras and security to prevent people from getting in. Why would any government agency have to go to such great extent to protect its workers unless there were a great number of citizens in this province who are angry at the kind of work your people do. I have heard that your department just goes ahead and does what it wants without any concern for the harm your actions are doing to children and families.

If there is one thing I have learned in the past few years is that the FRO is often used as a weapon by custodial mothers to get revenge on their former spouses and is used to throw families into financial ruin. Often the FRO is abused at great expense to the taxpayers of this province to destroy families and to throw fathers into financial ruin. This is a disgrace to the people of Ontario.

Many newspaper articles seem to reflect what many others have told me about your department. I have read the story of Andrew Renouf who killed himself after writing a suicide note saying that he killed himself because of the FRO. I have spoken to other individuals who have attempted suicide because of the FRO. I understand that one of your clients, a Mr. Marvin Davids of Thornhill committed suicide earlier this year after being hunted down by your gang of hoodlum collection agents after being profiled with the Toronto Star newspaper. You are like the Mafia, except with government support.

The bottom line is that if the court and government agencies such as the FRO did their job in a fair and just manner then people would have faith in the court system and people like myself would not be fighting your agency. Through my experience, I see that the family court system is corrupt and not worthy of the respect of the people of Canada. Court transcripts have gone mysteriously missing in my case and bias and corruption by lawyers and judges is very apparent to many people. Government agencies such as the FRO are supposed to be working for the betterment of the children and families in this province, not forcing dads into financial ruin and forcing them to commit suicide. Any government agency that is responsible for such gross atrocities against its own people should be destroyed, just as was the Berlin Wall a number of years ago when the people rose up against their communist masters.

I am not working and have recently gone bankrupt as a result of the attorney generals office filing a report that was biased and fundamentally flawed, if not perfidious with the Court recommending sole custody to the Mother. Although I am doing what I can for the betterment of my children, all the FRO wants to do it to see what it can do to cause more hardship on my family by taking away my drivers license and causing even more hardship on my children and their father.

Again, I ask you to provide me with a copy of the judge's original handwritten endorsement ordering you to intrude into my family's affairs. If your department continues to harass me over a matter which I do not feel that you have the legal authority to do so, then I will take legal action against the FRO and the Ministry of Community and Social Services. Showing me proof of your authorization in the form of proper court document would certainly help to clear this matter up.
