Dear Sir, or Madam,

My name is Sadrudin Chatur, I, am single Father of 4 bi-racial children residing in the City of Burlington, Ontario. I am Canadian citizen who is appalled at the **devastation** caused to children, including mine and their relationships with parents in this province. I consider the devastation both a "Conspiracy" and fraud perpetrated by our judges who are sworn to duty.

I am requesting your help to investigate what I believe is an ongoing "Conspiracy" committed by the Superior Court House judges in Ontario, more particularly the fraud which is being perpetrated by the judges against to the tax payers of this province and the children of this province. Although the matter is wide spread, I will address more specifically the matters in the Milton Court Judges, namely:

- A) Justice McDonald Makenzie.
- B) Justice Linda Templeton.
- C) Justice Langdon

I make mention of specific names because they through the act of "Conspiracy" cost taxpayers MILLIONS of dollars.

Background

In 1992 during a custody hearing, my former spouse alleged that I had sexually molested my 2-year-old daughter, this continued for 13 times and 13 subsequent investigations.

Various service providers and agencies including the police investigated that there were no "wrong doings" and that the mother was inconsistent with her evidence. I believe there were over of 20 "investigators" investigating this case at tax payers expense and never was there any counter charges laid for public mischief. Never once did the judge over turn custody, which should have been paramount to the best interest of our children.

This problem is evident in many ongoing protracted cases before the family courts in this province, including mine. As a Canadian, I have difficulty understanding why this sort of action is “PROMOTED” by our judiciary and while the police do nothing about it. I believe that charges should be laid against various service providers including the Children Aid Societies and it’s

members, the police force who do nothing about this sort of crime, judges for contributing the abuse of process and abuse of children, the Office of the Children’s lawyer and others who directly contribute the demise of the children who we are supposed to be protecting.

It is inappropriate that anyone’s Human Rights are violated and that further alleging false sexual abuse allegations and involving service providers at no cost to the perpetrator/s. The allegations serves only to cause a “**feeding frenzy**” among the provider’s which ultimately effects the best interest of the children and my loving relationship with my children. This must stop and the protecting the children must again be restored.

My case is a case in point, which exemplifies how many service providers including the mother has benefited both financially and at taxpayers expense. This must be put to an end and I request that at the very least charges be laid against those who perpetrated a crime. This would include all those mentioned herein. This problem has been going on for 10 years, how many more years will the system permitted this sort of “Conspiracy” to go on unchecked. The person who makes false “sexual abuse” allegation must not be rewarded for their ill preconceived actions!

There is ample evidence that the mother **knowingly coached** the child of the marriage to lie in order to gain control of the ongoing custody dispute in family court. She utilized the system in an “ill” manner at taxpayers expense at our children’s expense in attempts to use “bureaucratic” weapons of destruction and at no expense to her.

In or around April of 2000 my former spouse obtained Legal aid and **again lied to the police that I had molested two of my daughters**, the CAS and the Police investigated, and again reported that the mother was not a credible witness. They concluded that the mother coached the children to lie. One of my daughter’s described to the police that the mother had written 2 letters and had her read the content to the CAS and the Police. I understand that the entire interviews of the Police investigation were video taped.

Despite all the evidence a Family Court Judge in Milton ordered me to stay away from my Children, despite evidence to the contrary. I believe the judges have conspired against gender lines to rule and make orders against the wishes of parliament with respect to law, against me and in doing so provide a means by which the best interest of the children is thwarted.

There have been direct communications between her solicitor and judges,

Tapes have gone missing from the Court Reporters Office,

There have been altered transcripts,

There has been open denial of justice,

There have been racial remarks made,

There is a clear bias in the courts,


There have been Court Orders obtained illegally,
