**Dear Secretary General,**

**Subject: CRIMES AGAINST HUMANITY IN CANADA - VIOLATIONS OF OUR RIGHTS AND FREEDOMS**

**I have exhausted all other avenues within Canada, in a desperate attempt to correct the daily horrific violations of our Charter of Rights and Freedoms, constantly perpetrated against us because we are Men, by our Canadian Judiciary and Canadian Government.**

**Our Canadian Government and our Canadian Judicial Council, have deliberately ignored countless pleas from Canadian families, to justifiably correct the Anti-Male bias and Gender Discrimination executed daily in Canada's Family Courts.**

**Furthermore, many Men, including myself, have been continually discriminated against in other areas of "Equality Rights", as declared in Section 15.(1) of the "Canadian Charter of Rights and Freedoms", signed by our former Prime Minister, the late Pierre Trudeau, in 1981. For example, I have been discriminated against not only because I am a man, but because I am also ill. That is probably the lowest form of Discrimination that there is, because it is impossible for you to defend yourself.**

**Thousands of Canadian Men, in past years, have been driven to suicide by the Family Courts and Canadian Men continue to die at an appalling rate. I have also been driven to attempt suicide.**

**Our Children are suffering to an extent beyond belief solely because of this Anti-Male bias and Gender Discrimination executed both in our Courtrooms, and by our Canadian Government. It is common knowledge that more than 50% of marriages end in divorce in Canada, therefore 50% of our children, and eventually our Grandchildren, will be affected one way or another.**

**It is also common knowledge that once Lawyers and Judges become involved, the personal and financial gain of these individuals will be foremost in the Court proceedings, NOT the best interests of the children. Please ask us for our true, and very tragic, stories. I can provide you with endless accounts. Children always inevitably lose. We can prove it.**

**To summarize the facts, our "Canadian Charter of Rights and Freedoms" has been made a mockery of by our Canadian Government, our Judiciary, and our Lawyers.**

**I have enclosed just a portion of my own correspondence which I have also sent to Senator ...ne Cools, relating to the multiple Court Orders regarding the break-down of my own marriage in 1987.**

**My situation in Court, regarding Spousal Support, is no different today as to what it was, many years ago. Why? When will this fiasco ever end? Perhaps when I am bankrupt and deceased. Perhaps not even then!**

**There are two main reasons for my letter to you.**

**The first reason is to draw your attention to the Anti-Male bias and constant Gender Discrimination in our Canadian Courts. These are clearly "Crimes Against Humanity" and they are totally unacceptable to anyone, in any country, in this day and age. One cannot ignore the facts.**

**The second reason is to ask you how I, along with the thousands of other Canadians, can proceed with our justified complaints to the United Nations, regarding these violations of our Human Rights. Is there a standard Form that we should complete for submission to you? What information is required of us? We will pursue relentlessly until real Justice is achieved.**

**I know that I am literally risking my own future regarding my case in Court, perhaps even my life, by writing directly to you and asking for your assistance.**

**The fact is, I have already been threatened by one Judge in Toronto. He was extremely angry because I had written to the Canadian Government in the past regarding my divorce case. I had been attempting to bring the true horrifying major issues of Anti-Male bias and Gender Discrimination in our Courts to the forefront, for immediate correction.**

**It was quite clear that this particular Judge felt that I was an obvious threat to his future personal career in the Family Court. He was definitely not prepared to allow anyone to disrupt it, even though there was a distinct justification for the complaints.**

**I now wish to bring to your attention the case of Mr. Peter Cornakovic. Please read the press release, and Canada Court Watch Report, attached directly to this letter. This true story is absolutely horrifying. Mr. Cornakovic has been persecuted, and continues to be persecuted, beyond belief.**

**In addition, something serious, which you should certainly be informed of, happened yesterday on Wednesday, July 10th., 2002 at the Milton Courthouse.**

**I was accompanying Mr. Peter Cornakovic, together with his family and friends, to the Family Court in Milton, Ontario for the sole purpose of moral support during a Motion which had been scheduled for 10:00am.**

**The Court Officials were very much aware at 10:00am yesterday morning that I had personally written to Senator Cools, and multiple members of the Canadian Government, lodging justified complaints against our tyrannical Family Courts in Canada. It is quite obvious that Madame Justice Seppl had been advised accordingly.**

**The Court Officials also knew that I was in the process of writing directly to you for help. Everyone knew that I was requesting advice on how Canadians should register their complaints of Crimes against Humanity, and other Human Rights Violations in Canada, with the United Nations.**

**Yesterday, during a court recess at approximately 12:45pm., two armed Police Officers came up to me, in front of many other members of the public, and they requested identification from me. I was**

stunned, but remained calm. I was extremely embarrassed and I most certainly felt very threatened.

I am intelligent enough to know that the Police would be waiting for me to resist giving any information to them. I am also intelligent enough to use the appropriate language, which I was extremely cautious to do. Any inappropriate behavior on my part would have given the Police an excuse to arrest me and imprison me. That, I believe, is what they were hoping for.

To give you an idea of my own personal character, the worst thing that I can remember doing in my whole life of 55 years, was to receive a parking ticket.

I asked the two Police Officers the reason for their request for my ID but I received no response from either of them. One of the Police Officer's hands was just held out waiting to collect my ID. I then asked why no other person in our group was being questioned. In the simplest English language, I politely asked them, "Why Me?"

The only verbal response I received was "Madame Justice Seppi has instructed us to obtain your ID". I politely replied, "That's fine" and I quietly surrendered my Driver's License to them. I confirmed my current home address which was imprinted on my Driver's License as to being correct. I have nothing to hide from anyone. All I ever wanted in my life is real Justice.

This entire episode shocked me and instantly reminded me of the era of 1962 and 1963 set in Moscow, when a person from the western world would be stopped and interrogated by the KGB. I remember those days well. I never, ever thought that I would be stopped and questioned in this same manner in this "democratic" country of Canada WITHOUT ANY EXPLANATION.

After one of the two Police Officers had recorded my Driver's License number, they informed me that Madame Justice Seppi had stated that I was not allowed in her Courtroom, and I had to remain outside. Of course, we all know the dangerous part of me is that I always possess a pen and paper.

It was quite obvious to everyone around that I had committed no crime, neither was this questioning justified. Madame Justice Seppi obviously had a personal agenda and she did not wish me to witness anything, or note anything in her Court, that may be threatening to her personal career. It was safer for her to "dispose of me" by attempting to frighten me into silence. It will never work.

For the record, the Halton Regional Police Officers names and Badge numbers are as follows:-

1. Police Officer Bridges, Badge # 0177
2. Police Officer J. Woodworth, Badge # 7856

Once again my Human Rights had been violated. When will these violations end? Will I be shot to death by either a Judge or a Police Officer for making any notes about Family Court matters next time? Will I be stopped from owning a camera and a tape recorder?

To enlighten you about Canada, my very best friend is not white, and she and I (I happen to be white) have both been discriminated against on multiple occasions when we have been out together. However, that is another true horrifying story for another time. Please believe me, Canada is not what it is portrayed to be to the rest of the World. It is a sorrowful mess. This sad situation in the Courtroom area with the Police interrogation of me yesterday may have been much worse if my friend had been with me, knowing that she is not white. I am quite certain of that fact.

I emigrated to Canada from England in 1974 and I cannot believe what I have seen in this country. I

expected very much better.

**Regarding our broken-down, Anti-Male, Family Court system, it must be dealt with, and corrected immediately, for the sake of our Children, and our Grandchildren. People are dying unnecessarily every day while those in authority neither act nor listen. I am sure you will listen to us.**

Please help us and write to me and advise me as soon as possible, which path I, along with other Canadians should take, to correct these clear violations of our Human Rights in Canada.

It is painfully obvious to all of us that the violations will not be corrected internally in Canada, therefore we have been given no other choice but to pursue externally by requesting your immediate intervention.

I look forward to hearing from you as soon as possible.
